## PROTECTION OF THE INTELLECTUAL PRODUCT OF THE FOOD TECHNOLOGY INDUSTRY IN THE CONDITIONS OF GLOBALIZATION RISKS AND CRISIS PHENOMENA

## Summary

The purpose of the article is to search for and study the problems of ensuring the protection of an intellectual product in the food technology industry in the context of globalization risks and crisis phenomena.
